

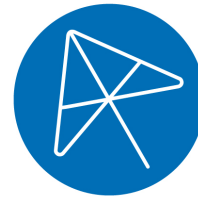

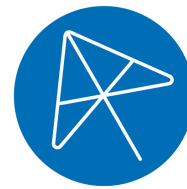

MINUTES

Meeting opened at 3.01pm AWST

1. Acknowledgement of Country

IAA Secretary, Matthew Enger (ME) opened the meeting with an Acknowledgement of Country.

2. Introduction and Welcome

IAA Chair, David Hooton (DH) declared quorum at the SGM and welcomed members to the meeting.

3. Agenda Overview

IAA CEO, Narelle Clark (NC) provided an overview of the agenda in accordance with the notice of meeting, and informed members how to raise questions and comments throughout the meeting.

4. Eligibility to Vote

NC provided an overview of Member eligibility to vote, as determined by Rule 50 (7) a) and b) of the IAA Rules, and that Members were advised of their individual standing on entering the meeting. Members were advised of how to query their eligibility where they thought it was incorrect. No member raised any questions regarding their eligibility.

5. Overview of Voting

NC provided an overview of the voting procedures to be followed during the meeting and the method to change a vote already cast online. NC reminded Members that under the Associations Incorporation Act 2015 [WA] 51.(1).(b), a special resolution is passed by the votes of not less than three-fourths of the members of the association who cast a vote.

6. Special Resolution 1

- DH read the first Special Resolution for consideration by members:
For the Lodgment of application for registration: to consider and, if thought fit, pass the following resolution as a Special Resolution:
That in view of the dispersed and Australia-wide nature of the operations of the Internet Association of Australia Inc (registration number A10049875), an application be made in accordance with section 93 of the Associations Incorporation Act 2015 (WA) and regulation 14 of the Associations Incorporation Regulations 2016 (WA) for it to apply for registration as a prescribed body corporate under Part 5B.1 of the Corporations Act 2001 (Cth) and an application be made under Part 5B.1 of the Corporations Act 2001 (Cth) for the Internet Association of Australia Inc to apply for registration as a company limited by guarantee with the proposed name of "Internet Association of Australia Ltd".
- DH called for someone to move the Special Resolution
 - o Matthew Moyle-Croft (MMC) moved the Special Resolution
- DH called for someone to second the Special Resolution
 - o Matthew Enger (ME) seconded the Special Resolution
- DH invited NC to give an overview of the process and timeline followed by IAA leading to the special resolution. NC provided an overview of the process of Member consultation to arrive



- at the final draft of the constitution and the timeline of communications and events.
- DH asked if any Members had any questions, and for any speakers for or against the Special Resolution.
 - o Question: How many members provided feedback in consultation.
 - o NC answered 14 members provided feedback and that feedback was overwhelmingly positive.
 - o No other questions.
 - DH reminded members of their eligibility to vote and the process to vote.
 - DH called for votes FOR the first Special Resolution
 - o Votes counted and recorded
 - DH called for votes AGAINST the first Special Resolution
 - o Votes counted and recorded
 - DH called for ABSTENTIONS for the first Special Resolution
 - o Votes counted and recorded

7. Results of Voting from Special Resolution 1

- Kitty Hibble presented the results of the vote for the first Special Resolution:
 - o There were 51 online votes received, there was 1 vote received during the meeting.
 - o In order to pass the Special Resolution with the required three-fourths majority, the votes needed FOR were 39.
 - o Of the 52 eligible votes, 43 were FOR, 8 were AGAINST and 1 was ABSTENTION
 - o 82.7% of the members who cast a vote voted FOR the Special Resolution.
- DH announced that on the basis of general agreement the first Special Resolution was carried with the required majority.

8. Special Resolution

- DH read the second Special Resolution for consideration by members:
To approve a constitution for the company: to consider and, if thought fit, pass the following resolution as a special resolution:
That the constitution, tabled at the special general meeting of the Internet Association of Australia Inc held on 28 July 2021 and initialed by the chair of the special general meeting for the purpose of identification (a copy of which was attached to the notice of the special general meeting), be approved for adoption as the constitution of the company "Internet Association of Australia Ltd", with the adoption of the constitution to take effect subject to and from when the Australian Securities and Investments Commission registers the company under Part 5B.1 of the Corporations Act 2001 (Cth), at which point the constitution shall completely replace the existing rules of the Internet Association of Australia Inc and which shall cease to apply from that date.
- DH called for someone to move the Special Resolution
 - o Matthew Moyle-Croft (MMC) moved the Special Resolution
- DH called for someone to second the Special Resolution
 - o Matthew Enger (ME) seconded the Special Resolution
- DH invited NC to give an overview of the proposed Constitution. NC provided an overview of the proposed Constitution and the major differences as compared to the existing IAA rules.
- DH asked if any Members had any questions, and for any speakers for or against the Special Resolution.
 - o Question: Re removal of directors by members.
 - o NC answered that under clause 10.9, voting members may by ordinary resolution remove a Director before the expiration of the Director's period of office.
 - o No other questions.



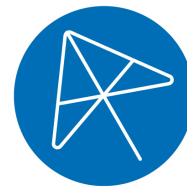

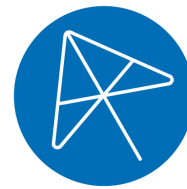
